

#### **Care Measures for ESRD Patients**

- There are several resources available that can help ESRD patients make choices about care, and where to have dialysis treatments based on quality measures
  - Quality Incentive Program (QIP)
  - Performance Score Certificate (PSC)
  - Five-Star Quality Rating System
  - Care Compare

# **Quality Incentive Program (QIP)**

- The Centers for Medicare & Medicaid Services (CMS) implemented the End-Stage Renal Disease (ESRD) Quality Incentive Program (QIP) in 2012 to help ensure that high quality healthcare is provided to all ESRD patients
- This program changes the way CMS reimburses for the treatment of patients who receive
  dialysis by linking a portion of payment directly to facilities' performance on quality of care
  measures
  - These types of programs are known as "pay-for-performance" or "value-based purchasing" (VBP) programs
- Facilities that do not meet performance standards are penalized between 0.5 percent and 2 percent on their Medicare reimbursement



# **Quality Incentive Program (QIP)**

What performance measures are included in the Calendar Year (CY) 2023 QIP?

- Clinical Care (40% of Total Performance Score)
  - Dialysis Adequacy (Kt/V)
  - Vascular Access Type
    - Standardized Fistula Rate \*
    - Long-Term Catheter (> 90 days) Rate ★
  - Hypercalcemia (uncorrected calcium)
  - Standardized Transfusion Ration (STrR) Reporting Measures
  - Ultrafiltration Rate (URR) Measure
- Care Coordination (30% of Total Performance Score)
  - Standardized Readmission Ratio (SRR) Measure \*\*
  - Standardized Hospitalization Ratio (SHR) Measure
  - Clinical Depression Screening & Follow-Up Reporting Measures
  - Percentage of Prevalent Patients Waitlisted (PPPW) Measure \*

# **Quality Incentive Program (QIP)**

  - NHSN Dialysis Event Reporting Measure
  - Medication Reconciliation (MedRec) Measure

# Performance Score Certificate (PSC)

- As part of the QIP, CMS adds up all the points each dialysis facility receives every year on performance measures (called the Total Performance Score) and gives your facility a Performance Score Certificate (PSC) containing the results
  - It is like a report card for your facility
- The PSC shows how well your facility has performed and compares its performance to other facilities across the country
- Look for the PSC in the lobby of your dialysis facility
  - Each facility must print the PSC and post both Spanish and English versions in a place where patients and caregivers can see
  - A new certificate should be posted at the end of every year
- If you have questions, ask any of the staff members at your facility about the ESRD QIP scores, including the Performance Score Certificate (PSC)



The Total Performance Score (TPS) is a single number that tells how a facility performed in the ESRD QIP and determines whether CMS will lower that facility's payments by up to two percent for an entire year. Along with other CMS ESRD programs, it provides information on the quality of care provided by facilities. Each facility earns points for its performance in 2019 based on one of two factors 1) how close the facility's performance is to the national median in 2017, and 2) how much the facility improved relative to its previous performance in 2018. Since the score can be calculated differently for each facility, the TPS should not be used alone to compare different facilities. Please use the Dialysis Facility Compare website for more information about comparing dialysis facilities in your area.

Dialysis facilities are required to post this certificate prominently in a patient area.

This certificate expires December 31, 2021.

# **Five-Star Quality Rating System**

- In 2013, the Centers for Medicare & Medicaid Services (CMS) launched the Five-Star Quality Rating System to help consumers make informed and educated decisions about where to receive dialysis care
- The Five-Star Quality Rating System uses data from dialysis facilities' Total Performance Score on the QIP (called the Quality Rating) to assign a star rating of 1 to 5 to each dialysis facility
  - In 2020, CMS added the ICH CAHPS survey score (called the Patient Survey Rating) to the Five-Star Quality Rating System, establishing a comprehensive assessment of care (quality of care and patient experience of care)


#### **Care Compare**





#### What is Donate Life Month?



National Donate Life Month (NDLM) was established by Donate Life America and its partnering organizations in 2003. Observed in April each year, National Donate Life Month helps raise awareness about donation, encourage Americans to register as organ, eye and tissue donors and to honor those that have saved lives through the gift of donation.

The year for National Donate Life Month (NDLM) 2023, Donate Life America was inspired by the natural world of a pond coming to life in the spring. Frogs (and toads!) are a sign of healing and renewal, and water lilies represent hope. The lily pads we see on the surface of a pond are part of a much larger plant rooted below the water. The water lily plant reminds us of the support and collaboration needed for hope to bloom.



## **Understanding Kidney Donation**

- A kidney transplant is a surgical procedure to place a kidney from a living or deceased donor into a person whose kidneys no longer function properly.
- A kidney transplant is used to treat kidney failure (also called end-stage renal disease, ESRD), a condition in which kidneys can function at only a fraction of their normal capacity.
   People with end-stage kidney disease need either dialysis or a kidney transplant to stay alive.
- Causes of kidney failure may include diabetes, polycystic kidney disease (PKD), chronic uncontrolled high blood pressure (hypertension), or chronic glomerulonephritis (an inflammation and eventual scarring of the glomeruli — the tiny filters within your kidneys).
- More than 90,000 people in the US are waiting for a kidney donation.



## **How Does A Living Donation Work?**

A person can live with only one kidney, living donation offers another choice for some transplant candidates. The average waiting time for a donor kidney from a deceased donor is 3 to 5 years. A kidney from a living donor offers patients an alternative to years of dialysis and time on the national transplant waiting list. With living donation, a patient may be able to receive a transplant in 1 year or less. After donation, the living organ donor's remaining kidney will enlarge, doing the work of 2 healthy kidneys.



## Who Can Be a Living Donor?

Family members are often the most likely to be compatible living kidney donors, but many people undergo successful transplants with kidneys donated from people who are not related to them. Living donors will have a full medical exam, must be at least 18 years old, and in good physical and mental health. Different transplant centers have different limits on who can donate. The Kidney Transplant Learning Center offers resources on how to prepare to make the living donor ask and/or to have a family member or friend serve as a living donor champion.




## The Process of Living Donation

- 1. Patients who are interested in receiving a living donation must find a living donor
- 2. Waiting time is based on finding a living donor and the time it takes to complete the medical evaluation
  - Living donors are fully evaluated:
    - i. To ensure donating a kidney will not cause more harm than good
    - ii. To test if they are a match for the patient

# What Happens If My Donor Isn't a Match For Me? Kidney Paired Donation!

 Your donor is matched to another person in need and another persons donor is matched to you





# **How Do I Find A Living Donor?**

- Living donation can come from someone who is emotionally related to the patient such as a good friend, spouse, or family member and it can also be from a stranger.
- You can ask <u>directly</u> or <u>indirectly</u>
  - Direct ask tends to be more of a challenge for patients but one out of every four people say they would be willing to donate an organ
  - There are many ways to ask indirectly for a living donation
    - 1 Ask your transplant center:
      - Do they have a platform they use to campaign for a donor?
      - 2. Can they help create a social media campaign for you?
    - 2. Ask someone you're close with to be your "champion" or "kidney coach" to share your story
    - 3. Use email or write letters
    - 4. Share your need for a living donor in the community
