Where should I go for dialysis treatment?

The Emergency Room at your local hospital is one place you can go. You may have other options, depending on the state you live in.

Check the table below to find out

- Where in your state you can go to receive dialysis treatments.
- If your state offers undocumented persons Emergency Medicaid for dialysis care in a dialysis clinic (ongoing, scheduled treatments), in a hospital, or both.
- How to apply for Emergency Medicaid in your state.

IMPORTANT: You do not need to have Emergency Medicaid in place before you receive care for an emergency event (dialysis). You can apply after the emergency has been taken care of. If you qualify for Emergency Medicaid, it will be applied back to the start of your emergency care.

You will find links to the Emergency Medicaid application for your state in the table below. The application process for Emergency Medicaid is simple.

REMEMBER: If your state does not allow for Emergency Medicaid to apply in the outpatient setting, you may still apply, but will be able to receive dialysis treatment in the hospital setting only.

There may be other ways for you to treat your kidney disease. These include home dialysis or transplant. Check the IPRO ESRD Network Program website for state and local resources.
