Guidelines for Managing Patients with Bed Bugs in Dialysis Facilities

Managing patients with bed bugs can be challenging. Facilities are responsible for ensuring that patients affected by bed bugs continue to receive access to care while minimizing the risk of infestation and spread within the facility. This guide provides steps that dialysis facilities can take to address concerns related to bed bugs.

Facility Instructions

Review the facility policy and procedure on pest control.

Schedule a meeting with the patient and/or family to address areas of concern.

Provide the patient with a letter of concern.

Preventative Strategies

Treat the patient in an isolation room if available. If an isolation room is not available, consider using a dialysis chair at the end of the treatment floor to best isolate bed bugs. Designate a specific chair for the patient's use only if possible.

Keep everything off the floor in the vicinity of the chair.

Limit the number of personal belongings that the patient brings into the facility.

Place the patient's belongings in a sealable bag and return items after treatment.

Consider investing in a heating box to treat the patient's belongings.

Perform routine inspections and work with pest control professionals.

Cover the dialysis chair with white paper to make it easier to identify bed bugs.

Consider using protective measures like disposable blankets and gowns for patients with known infestations.

Patient Instructions

Provide instructions to the patient to wash and dry their clothes on high heat, take a shower before scheduled treatment, and wear freshly washed and dried clothes after showering.

Offer resources and guidance to help the patient take necessary steps to manage bed bugs.

Assistance for Patients

If the patient resides in a rented home, verify with the patient if the owner will cover the cost/create a work order for fumigation services. Landlords may have a responsibility to do so.

Assist the patient in identifying sources of assistance for home fumigation.

Provide education and assistance with community resources if financial challenges are present.

Contact local pest control companies to inquire about reduced cost options or payment plans

Request a free home pest inspection from a local pest control company. Many smaller, local companies provide free inspections as a way to earn business.

Outreach to local church groups, Salvation Army, Catholic Charities

Inquire if the patient's home clinic offers financial assistance

Check with the lead regional social worker/teammates for additional local resources If the patient is a renter, check whether this is a covered incidence from the landlord, property group, or respective housing authority
